Revenue increase at Sistema-Hals

According to the financial results for the first six months of 2007, consolidated revenue for Sistema-Hals were up by 21.7% year-on-year, totalling USD 129.8 million.

Value of Sistema-Hals' share in real estate properties and development projects increases

According to an independent appraisal conducted by Cushman & Wakefield Stiles & Riabokobylko (C&WS&R), the value of Sistema-Hals' holding in real estate properties and development projects has risen by 41.3%, amounting to USD 2,882.0 million (as of July, 1 2007).

Sistema-Hals – a rapidly growing company

Sistema-Hals has joined the top 50 fastest growing companies in Russia. It is ranked number 8 in terms of earnings growth (turnover), having become the fastest growing development company in the country (the other developer, PIK, was placed at number 34 on the list). The ranking is published in the Russian RBC magazine.

“Sistema-Hals yesterday announced its second major regional project. Following on its Astrakhan commitment, the company plans to build in Nizhny Novgorod.
